1. NON-RESOLUTION BOARD ITEMS

President Scott Savage called the meeting to order at 8:31 a.m.

Mr. Scott Savage led the Pledge of Allegiance.

2. CONSENT AGENDA ITEMS

Mr. Fritz Byers made a motion including the disposition of the minutes for the regular Board meeting held on February 22, 2023 and the consent agenda for the meeting on March 22, 2023 with the addition of Resolution 28-23. This motion was seconded by Mrs. Lera Doneghy and approved.

3. CONSIDERATION OF REPORTS FROM DIRECTOR AND EMPLOYEES OF THE PARK DISTRICT FOR REVIEW

A. Park Visitation – Piloting a New Method – Nate Ramsey, Chief Operations Officer; Josh Brenwell, GIS Manager

Mr. Nate Ramsey shared a presentation on the new method being piloted for tracking park visitation.

Get Outside Yourself.

Your Clean, Safe, Natural Metroparks

Metroparks does not have a required point of entry such as a ticket gate, which necessitates utilizing a different method of counting visitors to the parks. Until recently, Metroparks has utilized a counting method that counted cars that passed through specific entrances at each park, which has proven to be not entirely reliable. This method utilizes an average multiplier to determine how many people per car to count which tallies to an overall estimate of visitation; this method has not accounted for walk-in or bike-in visitors to the park. The gate counters have started to fail in certain areas and have been difficult to replace due to supply chain issues.

The new method for tracking visitation utilizes new software, AirSage, which tracks anonymous voluntary data available from cell phone usage of people in a given location. This tracking generalizes neighborhoods where people live and can determine how many people are in a specific park and the general census block from which they came. This information is voluntary in that cell phone users must allow the apps on their phone to track their location; additionally, a person must open one of those apps while in the park in order for that visit to be counted. The GPS location information is completely anonymous, with all unique identifying information removed before AirSage and therefore Metroparks is able to see the general data.

Mr. Joshua Brenwell explained how the AirSage tracking system works, with "points of interest" plotted in the software which equate to the boundaries of each Metropark area. This will allow for GPS data to be tracked for visitors that cross within the boundaries of each plotted area, excluding employees whose location data is consistently noted within a certain point of interest. This system allows Metroparks to view more demographic information on where visitors live and the census data associated with the general neighborhoods from which visitors come. The system also tracks level of visitation on specific days and busiest times during the day, which can be useful for the Operations team to plan staffing and maintenance. Mr. Brenwell has created an overall dashboard to allow for aggregating the data collected for easier use by staff.

Mr. Ramsey explained that this new tracking method will help with tracking visitations to hard to delineate park areas, such as the Glass City Riverwalk. This will also help the park system determine if people from the neighborhoods surrounding each Metropark are utilizing the parks and how to better serve them, along with determining how out of state visitors are utilizing the parks. This spring, volunteers will be used to manually count cars and visitation in the parks to test the accuracy of the new system.

Ms. Molly Luetke echoed the usefulness of the data available through this system, and her interest in hearing a follow-up report on the data once it has been in use for a while longer. Mr. Byers shared that since the data is not real-time and is anonymous, it makes the data less invasive and more useful allowing Metroparks to better serve the public. Mr. Savage inquired into how visitation is counted for those visitors that do not use their phones while in the park; Mr. Ramsey indicated that the AirSage software has methods to account for that scenario in the estimated visitation.

B. Treasurer's Report - Matt Cleland, Chief Financial Officer/Treasurer

Mr. Matt Cleland shared that Federal Reserve rates have increased 2.25% since the estimates at the beginning of the year. Contract services has shifted back to what was expected, quickly adjusting from the increase at the start of the year. Mr. Byers inquired about the trajectory of fringe benefits; Mr. Cleland indicated that the cash flows are a bit uneven due to timing of payments, but generally tracks overall in line with salaries. Mr. Savage asked if the change in interest rates has affected the return on investments; Mr. Cleland indicated that there will not be a major effect, but there could be an effect on the issuance of bonds going forward. Mr. Savage inquired about the money market holdings and if the current banking environment would affect those; Mr. Cleland indicated that those holdings are diversified and protected based on requirements and Metroparks policies.

4. BOARD APPROVAL OF CONTRACTS, DEEDS, AGREEMENTS, ETC.

A. Mrs. Doneghy offered and moved for adoption of the following resolution, with a second by Mr. Byers:

Resolution No. 17-23 – Approval of Supplement and Amendment to the 2022 Certificate of Estimated Resources and Appropriations Measure

Mr. Cleland shared that these are appropriating additional funds that are not within the normal operating funds, including donated revenue from the Buckeye Fund and received grant funds to allow for use of those funds for their intended purposes.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

B. Ms. Luetke offered and moved for adoption of the following resolution, with a second by Mr. Kevin Dalton:

Resolution No. 18-23 – Ratification of Schedule of Payables

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

C. Mr. Dalton offered and moved for adoption of the following resolution, with a second by Ms. Luetke:

Resolution No. 19-23 – Request Approval to Declare Equipment Surplus (4000D)

Ms. Lisa Whitton shared that the current wide area mower will be declared surplus to allow for its sale to then provide funds for the purchase of a new mower.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

D. Mr. Byers offered and moved for adoption of the following resolution, with a second by Mrs. Doneghy:

Resolution No. 20-23 — Authorization for Long-term Capital Lease Agreements for two 2023 TORO Groundsmaster 4000D Wide Area Mowers

Ms. Whitton explained that two new wide area mowers would be leased for three years to be used in the West and Central regions for turf management.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

E. Mrs. Doneghy offered and moved for adoption of the following resolution, with a second by Ms. Luetke:

Resolution No. 21-23 – Request Approval to Declare Equipment Surplus (2000XL)

Mr. Ramsey explained that this chipper is well past its usable life and is in need of replacement.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

F. Ms. Luetke offered and moved for adoption of the following resolution, with a second by Mr. Dalton:

Resolution No. 22-23 – Authorization for Long-term Capital Lease Agreement for a 2023 Bandit Model 21XP

Municipal Chipper

Mr. Ramsey explained that this will be a new wood chipper to be used by the Natural Resources team to more efficiently manage the green waste produced from natural resource management processes.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

G. Mr. Dalton offered and moved for adoption of the following resolution, with a second by Mr. Byers:

Resolution No. 23-23 – Metroparks Toledo RFP Operations Cleaning Supplies 2023

Mr. Anthony Amstutz shared that this will allow for acquiring ecologically certified cleaning chemicals and supplies to be uniformly utilized across the park district. This will also allow for a uniform inventory management system across the park district. Mr. Byers inquired into the requirements for the ecologically certified aspect of the RFP process. Mr. Amstutz shared that those requirements for ecological certification were more heavily weighted in the bid tabulation system; the major components were the ecological certification and inventory management system.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

H. Mr. Byers offered and moved for adoption of the following resolution, with a second by Mrs. Doneghy:

Resolution No. 24-23 – Request of Funds from the Ohio Department of Transportation (ODOT) and Designation of Projects for Ohio Parks Districts Roadwork Fund, FY 2024-2025 through the Ohio Parks & Recreation Association OPRA

Mr. Doug Parrish shared that the State of Ohio levies a gas tax, of which a small portion is allocated to park districts based on vehicle registrations in each park area. These funds are to be utilized to maintain public access areas such as roads and parking lots. The Metroparks portion of these funds amounts to about \$200,000.00.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

I. Mrs. Doneghy offered and moved for adoption of the following resolution, with a second by Ms. Luetke:

Resolution No. 25-23 – Contract Approval, Glass City Riverwalk – Vistula Neighborhood Professional Community Engagement Consultant Services

Mr. Parrish shared that this contract approval will engage a consultant to aide in speaking with adjacent neighbors and stakeholders in the Vistula area to ensure their input is included in the planning for that portion of the Riverwalk. Metroparks wants to ensure the needs of the surrounding neighborhoods are met and incorporated into the planning. This will be partially funded through a grant from the Ohio Department of Natural Resources.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

J. Mrs. Luetke offered and moved for adoption of the following resolution, with a second by Mr. Dalton:

Resolution No. 26-23 – Contract Approval, Renovations for 4909 Jerome Road

Mr. Brad Hooven shared that this is a rebidding of the project after value engineering efforts to change the scope of the project. Mr. Byers inquired into the difference between the estimated cost and the actual bids; Mr. Hooven explained that because this project is connected to the other renovation project a cost savings is seen in the management of the project.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

K. Mr. Dalton offered and moved for adoption of the following resolution, with a second by Mr. Byers:

Resolution No. 27-23 – Contract Approval, Toledo Botanical Gardens Farmhouse Improvements

This will renovate the Farmhouse at Toledo Botanical Garden for additional office space.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

L. Mr. Byers offered and moved for adoption of the following resolution, with a second by Mrs. Doneghy:

Resolution No. 28-23 – Wilkins Road Storm Sewer Replacement Project Right of Entry Approval

Mr. Parrish explained that the Lucas County Engineers office is working on a storm sewer replacement project near the entrance of Oak Openings which will require access to Metroparks property to complete. This will provide formal permission for the engineers to enter Metroparks property.

After discussion and upon unanimous vote the resolution was declared duly adopted and recorded in the appendix to these minutes.

5. BOARD INITIATED TOPICS AND DISCUSSION

Mr. Savage introduced a guest to appear before the board, Mr. Hoag, to share a concern related to property near Swan Creek Metropark on Airport Highway. Mr. Hoag's concern is about the use of property in that location by a commercial entity which would like to relocate to the property despite current zoning ordinances. Mr. Hoag is requesting Metroparks to advocate with Toledo City Council and the Planning Commission on behalf of upholding the ordinance and ensuring that the intended business does not move into the area. Mr. Byers expressed his appreciation for Mr. Hoag bringing this matter to the Board's attention.

Ms. Savage shared that the Metroparks Ranger department has received a Safe Policing Certificate from the State of Ohio, reflecting the superior work of the Rangers in community policing. Mr. Dalton shared praise he had received for the rangers in the East region who had assisted in a recent fire situation.

Mr. Dave Zenk introduced the newest Metroparks staff member, Mr. Alex Cook, asset and maintenance forecast manager with the planning and construction team.

With no further business or action to be taken, Mrs. Doneghy made a motion to adjourn the Board meeting at 9:38 a.m., which was seconded by Ms. Luetke and approved.

1. Revenues, Expenditures and Changes in Fund Balances – Budget vs. Actual – General Fund as of 03/31/2023

<u>Description</u>: This report is a comparison of the General Fund budgeted revenues, expenditures and transfers compared to actual revenues, expenditures and transfers by month as well as year-end. The approved 2023 general operating fund budget and actual cash basis revenues, expenditures and transfers are represented. Year to date budget distribution is based upon a 12 month proration with the exception of salaries and fringe benefits. Salary and fringe benefit budget distribution is based upon a proration of 26 pay dates. (See Appended Statement – Attachment A).

<u>Current State</u>: Revenue is trending as expected. Annual pay increases and retro payments took place in March, which closed budget to actual variances. Increased utility expense is attributed to heating fuel across the District as well as water and electric at Glass City.

2. Receipts, Disbursements and Changes in Fund Balances – Budget vs. Actual – All Funds as of 03/31/2023

<u>Description</u>: This report is a comparison of annual budgeted receipts and disbursements compared to cash basis actuals as of month end. The General, Education/Programming, and Debt Service funds are presented as individual columns. The Grant Funds, Land Acquisition/Development, Capital Construction and All Other Funds columns are each summaries of multiple funds. The far right column is a total of all funds. General fund budget and actual numbers presented in this report are consistent with those presented in the report listed above. (See Appended Statement -- Attachment B).

Current State: All funds BVA is trending as expected.

3. Fund Advances Report – All Funds as of 03/31/2023

<u>Description</u>: This is a report of inter-fund, Board approved advances activity. Advances are made to support reimbursement grants and activities that would otherwise result in negative fund balances. Advances are returned following the receipt of grant reimbursement revenue.

DESCRIPTION:

The 2023 Annual Appropriations Measure was approved by the Board at the November 2022 Board Meeting and subsequently amended. Additional supplements to the 2023 Certificate of Estimated Resources and Appropriations Measure are needed to address supplements as summarized below. The affected line item appropriations and Certificate of Estimated Resources are attached.

The affected funds are as follows:

Fund 202 – Buckeye

Increase appropriations in the amount of \$11,413 to support various donation supported initiatives. This increase brings the total of appropriations in fund 202 to \$2,822,776.

Fund 256 – Federal Grants – USEPA Maumee AOC GLRI MAP5 & MAP6 Secor Prairie Ditch

Increase appropriations in the amount of \$39,623 to support restoration work at the Secor Expansion. This increase brings the total of appropriations in fund 256 to \$29,605,870.

Fund 258 - Local and Other Grants - Toledo Roadrunners 5K Course

Increase appropriations in the amount of \$4,000 to designated 5K running courses. This increase brings the total of appropriations in fund 258 to \$82,712.

<u>Fund 258 - Local and Other Grants - Water Resource Restoration Sponsor Program Akron - Secor Expansion</u>

DESCRIPTION:

The existing artificial turf surfacing at Swan Creek Metropark playground originally installed in 2014 has exceeded its useful service life and has been deemed necessary for replacement by Metroparks Certified Playground Safety Inspector staff.

The Scope of Work includes the installation of 2,072 square feet of poured-in-place rubber surfacing at varied depths on a compacted stone sub-base. The total cost for the project is anticipated to be \$63,096.00, which includes the vendor contract (\$57,360.00) and ten percent (10%) contingency (\$5,736.00). This purchase will be made through the U.S. Communities Government Purchasing Alliance, an OMNIA cooperative purchasing organization partnered with Metroparks, using an established contract of competitively solicited and publicly awarded playground products and services.

RECOMMENDATION:

Contract approval with GameTime, Inc. for replacement of poured-in-place rubber surfacing at Swan Creek Metropark playground not-to-exceed \$63,096.00 (contract amount + ten percent (10%) contingency).

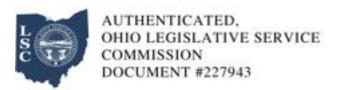
In accordance with *O.R.C.* 153.65(D) and 153.68, Metroparks Toledo currently utilizes a qualification based selection (QBS) procedure when hiring an architect, engineer or other design professional to perform professional services. Metroparks staff do not currently prequalify or maintain a qualifications list of prequalified individuals or firms and would like to advertise and establish a formal list. This will provide a distribution list for notification when Metroparks is in need of professional services for a project or program and allow for direct selection from the prequalified list in accordance with *O.R.C* 153.71. In accordance with Board Policy#23-Diversity in Procurement of Good and Services, this will provide Metroparks staff a list of MBE/DBE individuals and firms to maximize practicable opportunities for providing professional services.

A draft legal notice requesting statements of qualifications has been provided to the Board and will be published for a two week period in a newspaper of general circulation. The intent is that prequalification will be updated at least every two years.

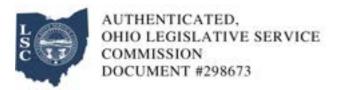

Section 153.68 Instituting prequalification requirements.

Effective: November 24, 1995

Legislation: House Bill 231 - 121st General Assembly

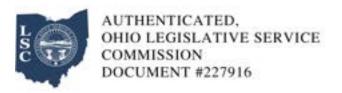
Any public authority planning to contract for professional design services may institute prequalification requirements for professional design firms seeking to provide services to the public authority and may require that each prequalified firm maintain a current statement of qualifications on file with the public authority. The prequalification requirements shall be based on factors such as those set out in division (D) of section 153.65 of the Revised Code.



Ohio Revised Code Section 153.71 Administrative rules.

Effective: September 13, 2022 Legislation: House Bill 687

- (A) Any public authority planning to contract for professional design services or design-build services may adopt, amend, or rescind rules, in accordance with Chapter 119. of the Revised Code, to implement sections 153.66 to 153.70 of the Revised Code.
- (B) Sections 153.66 to 153.70 of the Revised Code do not apply to any of the following:
- (1) Any project with an estimated professional design fee of twenty-five thousand dollars or less;
- (2) Any project with an estimated professional design fee of more than twenty-five thousand dollars but less than fifty thousand dollars if both of the following requirements are met:
- (a) The public authority selects a single design professional or firm from among those that have submitted a current statement of qualifications within the immediately preceding year, as provided under section 153.68 of the Revised Code, based on the public authority's determination that the selected design professional or firm is the most qualified to provide the required professional design services;
- (b) The public authority and the selected design professional or firm comply with division (B) of section 153.69 of the Revised Code with respect to the negotiation of a contract.
- (3) Any project determined in writing by the public authority head to be an emergency requiring immediate action including, but not limited to, any projects requiring multiple contracts let as part of a program requiring a large number of professional design firms of the same type.

Section 153.65 Professional design services definitions.

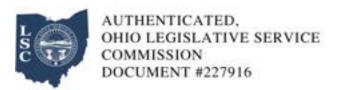

Legislation: House Bill 51 - 130th General Assembly

As used in sections 153.65 to 153.73 of the Revised Code:

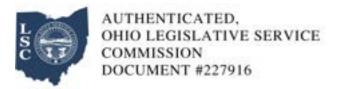
(A)(1) "Public authority" means the state, a state institution of higher education as defined in section 3345.011 of the Revised Code, a county, township, municipal corporation, school district, or other political subdivision, or any public agency, authority, board, commission, instrumentality, or special purpose district of the state or of a political subdivision.

- (2) "Public authority" does not include the director of transportation when exercising the director's authority to prepare plans for, acquire rights-of-way for, construct, or maintain roads, highways, or bridges.
- (B) "Professional design firm" means any person legally engaged in rendering professional design services.
- (C) "Professional design services" means services within the scope of practice of an architect or landscape architect registered under Chapter 4703. of the Revised Code or a professional engineer or surveyor registered under Chapter 4733. of the Revised Code.
- (D) "Qualifications" means all of the following:
- (1)(a) For a professional design firm, competence to perform the required professional design services as indicated by the technical training, education, and experience of the firm's personnel, especially the technical training, education, and experience of the employees within the firm who would be assigned to perform the services;
- (b) For a design-build firm, competence to perform the required design-build services as indicated by the technical training, education, and experience of the design-build firm's personnel and key consultants, especially the technical training, education, and experience of the employees and



consultants of the design-build firm who would be assigned to perform the services, including the proposed architect or engineer of record.

- (2) Ability of the firm in terms of its workload and the availability of qualified personnel, equipment, and facilities to perform the required professional design services or design-build services competently and expeditiously;
- (3) Past performance of the firm as reflected by the evaluations of previous clients with respect to such factors as control of costs, quality of work, and meeting of deadlines;
- (4) Any other relevant factors as determined by the public authority;
- (5) With respect to a design-build firm, compliance with sections 4703.182, 4703.332, and 4733.16 of the Revised Code, including the use of a licensed design professional for all design services.
- (E) "Design-build contract" means a contract between a public authority and another person that obligates the person to provide design-build services.
- (F) "Design-build firm" means a person capable of providing design-build services.
- (G) "Design-build services" means services that form an integrated delivery system for which a person is responsible to a public authority for both the design and construction, demolition, alteration, repair, or reconstruction of a public improvement.
- (H) "Architect or engineer of record" means the architect or engineer that serves as the final signatory on the plans and specifications for the design-build project.
- (I) "Criteria architect or engineer" means the architect or engineer retained by a public authority to prepare conceptual plans and specifications, to assist the public authority in connection with the establishment of the design criteria for a design-build project, and, if requested by the public authority, to serve as the representative of the public authority and provide, during the design-build project, other design and construction administration services on behalf of the public authority, including but not limited to, confirming that the design prepared by the design-build firm reflects the



original design intent established in the design criteria package.

(J) "Open book pricing method" means a method in which a design-build firm provides the public authority, at the public authority's request, all books, records, documents, contracts, subcontracts, purchase orders, and other data in its possession pertaining to the bidding, pricing, or performance of a contract for design-build services awarded to the design-build firm.

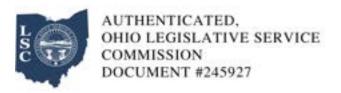
When the park district uses competitive sealed proposals, the Metropark Board is required to take some action to "give notice" of the request for proposals (see O.R.C. 307.862). The contracting authority must give notice of the request for proposals in the same manner that notice must be given for competitive bidding pursuant to section 307.87 of the Ohio Revised Code.

To avoid a cumbersome process of seeking approval for every advertisement/ invitation to bid, the Board may consider passing a Resolution delegating this authority to a specific individual or office. That individual/ office could then give notice on behalf of the Board, but the notice must include language that the Board reserves the right to reject all bids, and no contract may be implied, or awarded, until approved by the Board in an open meeting.

RECOMMENDATION:

Pass Resolution assigning authority to advertise and solicit formal bids to the Metropark Executive Director on behalf of the Board of Park Commissioners.

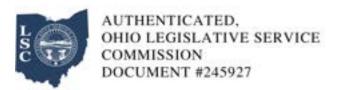

Section 307.862 Competitive sealed proposals - procedure.

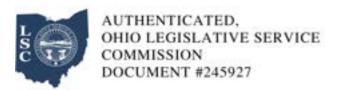
Effective: March 22, 2012

Legislation: House Bill 225 - 129th General Assembly

- (A) When a county contracting authority uses competitive sealed proposals pursuant to section 307.86 of the Revised Code, the county contracting authority shall do all of the following:
- (1) Develop factors and criteria to receive and evaluate each proposal, specify the relative importance of each factor or criterion in writing, and describe the evaluation procedures the contracting authority shall follow when awarding a contract to an offeror.
- (2) Solicit competitive sealed proposals through a request for proposals;
- (3) Include, at a minimum, all of the information described in division (B) of this section in the request for proposals;
- (4) Give notice of the request for proposals in the same manner that notice must be given for competitive bidding pursuant to section 307.87 of the Revised Code. The county contracting authority also may give notice of the request for proposals and receive proposals through a uniform, interactive, and secure electronic system in a manner consistent with Chapter 1306. of the Revised Code.
- (5) Open proposals that the contracting authority receives in a manner that prevents the disclosure of contents of competing offers to competing offerors;
- (6) Rank each proposal using the factors and criteria the contracting authority develops pursuant to division (A)(1) of this section;
- (7) If necessary, conduct discussions with offerors for the purpose of ensuring full understanding of, and responsiveness to, the requirements specified in the request for proposals, and accord fair and equal treatment with respect to any opportunity for discussion with offerors to provide any clarification, correction, or revision of proposals;

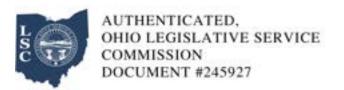


- (8) If the contracting authority determines that discussions described in division (A)(7) of this section are necessary, avoid disclosing any information derived from proposals submitted by competing offerors during those discussions;
- (9) Negotiate with the offeror who submits the proposal that the contracting authority determines is the most advantageous to the county based on the rankings performed by the contracting authority pursuant to division (A)(6) of this section and including any adjustment to those rankings based on discussions conducted pursuant to division (A)(7) of this section;
- (10) Conduct negotiations with only one offeror at a time;
- (11) Except as provided in division (F) of this section, award a contract in accordance with division (E) of this section.
- (B) A contracting authority shall include, at a minimum, all of the following information in the contracting authority's request for proposals:
- (1) The name and address of the department, office, institution, board, or commission that is requesting to purchase supplies, services, or both;
- (2) Instructions for offerors to follow when submitting proposals;
- (3) Instructions governing communications between an offeror and the contracting authority, including, but not limited to, the name, title, and telephone number of the person to whom questions concerning the request for proposals should be directed;
- (4) A description of the scope of work that the contracting authority requests an offeror to perform or supplies the contracting authority plans to purchase;
- (5) To the extent possible, a description of the performance criteria the contracting authority shall require an offeror to satisfy, including but not limited to, the quantity of the supplies, services, or both, to be purchased; the requirements the contracting authority shall follow for inspection and



acceptance of the supplies, services, or both; and the delivery schedule for each such supply or service;

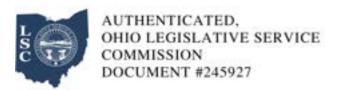
- (6) The factors and criteria the contracting authority shall consider in evaluating proposals received;
- (7) Any terms and conditions that the contracting authority is required by law to include in the contract the contracting authority awards, including any requirement for a bond and the amount required for that bond;
- (8) The date and time by which, and the place to which an offeror must deliver the offeror's proposal to the contracting authority in order to be considered for the contract;
- (9) A list of any documents that the contracting authority incorporates by reference in the request for proposals, provided that the contracting authority specifies in the request for proposals that the documents are readily available to all offerors and the location where an offeror may obtain those documents;
- (10) A statement that includes all of the following information:
- (a) That the contracting authority reserves the right to reject any proposal in which the offeror takes exception to the terms and conditions of the request for proposals; fails to meet the terms and conditions of the request for proposals, including but not limited to, the standards, specifications, and requirements specified in the request for proposals; or submits prices that the contracting authority considers to be excessive, compared to existing market conditions, or determines exceed the available funds of the contracting authority;
- (b) That the contracting authority reserves the right to reject, in whole or in part, any proposal that the county contracting authority has determined, using the factors and criteria the contracting authority develops pursuant to division (A)(1) of this section, would not be in the best interest of the county;
- (c) That the contracting authority may conduct discussions with offerors who submit proposals for the purpose of clarifications or corrections regarding a proposal to ensure full understanding of, and



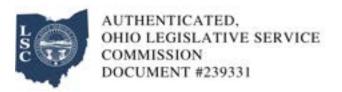
responsiveness to, the requirements specified in the request for proposals.

- (11) Information concerning any potential partial or multiple party awards that the contracting authority may include in the contract, and a description of the supplies, services, or both that may be subject to a partial award or multiple awards;
- (12) Any additional information the contracting authority considers necessary for its purposes in determining to whom to award the contract.
- (C) In order to ensure fair and impartial evaluation, proposals and any documents or other records related to a subsequent negotiation for a final contract that would otherwise be available for public inspection and copying under section 149.43 of the Revised Code shall not be available until after the award of the contract.
- (D) An offeror may withdraw the offeror's proposal at any time prior to the award of a contract. A contracting authority may terminate negotiations with an offeror at any time during the negotiation process if the offeror fails to provide the necessary information for negotiations in a timely manner or fails to negotiate in good faith. If the contracting authority terminates negotiations with an offeror, the contracting authority shall negotiate with the offeror whose proposal is ranked the next most advantageous to the county according to the factors and criteria developed pursuant to division (A)(1) of this section.
- (E) A county contracting authority may award a contract to the offeror whose proposal is determined to be the most advantageous to the county, taking into consideration the evaluation factors and criteria developed pursuant to division (A)(1) of this section and set forth in the request for proposals. A contracting authority may award a contract in whole or in part to one or more offerors. The contracting authority shall include a written statement in the contract file stating the basis on which the award is made.

The contracting authority shall send a written notice to the offeror to whom it wishes to award the contract and shall make that notice available to the public. Within a reasonable time period after the award is made, the contracting authority shall notify all other offerors that the contract has been awarded to another offeror.



- (F) A contracting authority may cancel or reissue a request for proposals if any of the following apply:
- (1) The supplies or services offered through all of the proposals submitted to the contracting authority are not in compliance with the requirements, specifications, and terms and conditions set forth in the request for proposals;
- (2) The prices submitted by the offerors are excessive compared to existing market conditions or exceed the available funds of the contracting authority;
- (3) The contracting authority determines that award of a contract would not be in the best interest of the county.
- (G) A county contracting authority shall not use competitive sealed proposals for contracts for construction, design, demolition, alteration, repair, or reconstruction of a building, highway, drainage system, water system, road, street, alley, sewer, ditch, sewage disposal plant, waterworks, and all other structures or works of any nature by a county contracting authority.
- (H) Nothing in this section limits a county contracting authority's ability to award a contract under this section through the use of a uniform, interactive, and secure electronic system.

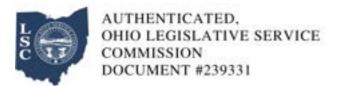
Section 307.87 Notice of competitive bidding.

Effective: September 28, 2012

Legislation: House Bill 509 - 129th General Assembly

Where competitive bidding is required by section 307.86 of the Revised Code, notice thereof shall be given in the following manner:

- (A) Notice shall be published once a week for not less than two consecutive weeks preceding the day of the opening of bids in a newspaper of general circulation within the county for any purchase, lease, lease with option or agreement to purchase, or construction contract in excess of fifty thousand dollars. The contracting authority may also cause notice to be inserted in trade papers or other publications designated by it or to be distributed by electronic means, including posting the notice on the contracting authority's internet site on the world wide web. If the contracting authority posts the notice on that location on the world wide web, it may eliminate the second notice otherwise required to be published in a newspaper of general circulation within the county, provided that the first notice published in such a newspaper meets all of the following requirements:
- (1) It is published at least two weeks before the opening of bids.
- (2) It includes a statement that the notice is posted on the contracting authority's internet site on the world wide web.
- (3) It includes the internet address of the contracting authority's internet site on the world wide web.
- (4) It includes instructions describing how the notice may be accessed on the contracting authority's internet site on the world wide web.
- (B) Notices shall state all of the following:
- (1) A general description of the subject of the proposed contract and the time and place where the plans and specifications or itemized list of supplies, facilities, or equipment and estimated quantities can be obtained or examined;



- (2) The time and place where bids will be opened;
- (3) The time and place for filing bids;
- (4) The terms of the proposed purchase;
- (5) Conditions under which bids will be received;
- (6) The existence of a system of preference, if any, for products mined and produced in Ohio and the United States adopted pursuant to section 307.90 of the Revised Code.
- (C) The contracting authority shall also maintain in a public place in its office or other suitable public place a bulletin board upon which it shall post and maintain a copy of such notice for at least two weeks preceding the day of the opening of the bids.

DESCRIPTION:

At the October 27, 2021 regular meeting of the Board, Resolution 91-21 was duly adopted approving a construction contract with Comte Construction Co. of Toledo for \$651,750.00 (contract amount + ten percent (10%) contingency).

The Scope of Work consists of fire damage repairs and new construction of a 3,000 sq. ft. preengineered metal building addition to replace the fire damaged portion of the existing maintenance structure at Secor Metropark. General construction involves the general building trades plus plumbing, mechanical and electrical.

Additional work covered via approved change orders includes permit/code required changes resulting in an additional man-door with exit signage, flood vents, drinking fountain, additional demo and roof replacement, and additional site aggregate. Other changes include electrical service upgrades, washer, dryer, and sink accommodations, and hot water hose bib.

Any future change orders result in an increase above and beyond the previously approved ten percent (10%) contingency. 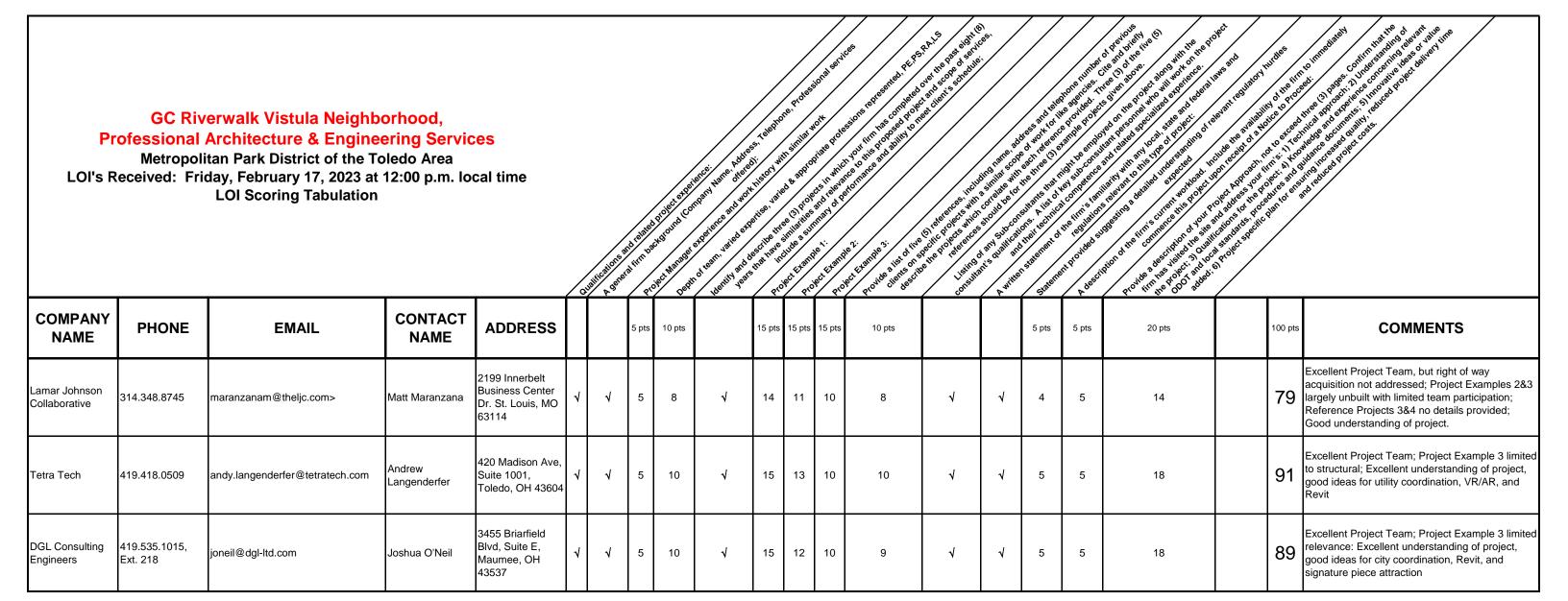

The Scope of Work consists of providing professional A&E design services to produce schematic design options, design development and construction documents for up to four rustic, nautical-themed cabins at 1821 Front Street, Toledo, OH 43605, as part of the Urban Campground phase of Glass City Metropark. In general, the Consultant shall work cooperatively with the Owner and Construction Manager At-Risk (Lathrop) to complete normal architectural, structural, mechanical, electrical engineering, and interior design for the design and construction documents necessary to complete the Project.

With the Urban Campground phase of Glass City Metropark, Metroparks Toledo aims to create a unique, exciting, and affordable camping opportunity that engages visitors with both the Maumee River and the heart of downtown. DESCRIPTION:

The Oak Openings Region is home to more rare and endangered plant and animal species than any other comparably-sized area in Ohio. Many of these species rely on the region's unique prairie and savanna habitats which have persisted for thousands of years due in large part to natural disturbances such as wildfires and grazing by large herbivores (bison and elk). By the mid-1800s, both of these natural disturbance regimes had been disrupted due to land use conversion and extirpation of large herbivores. Beginning in the 1980s Metroparks reintroduced prescribed fire to manage its prairies and savannas at Oak Openings Preserve. Beginning in 2022, Metroparks implemented a controlled grazing study in collaboration with Black Swamp Cattle Company to determine the effectiveness of grazing has a habitat management and restoration tool on 10.8 acres at Oak Openings Preserve.

As a continuation of the grazing study initiated in 2022, Metroparks intends to enter into a grazing lease with Black Swamp Cattle Company (Lessee) for the 2023 on an approximately 27-acre area as identified in the attached lease agreement. Under the terms of the lease, Metroparks is responsible for erecting a perimeter fence and providing a water supply. Lessee is responsible for stocking the grazing area with cattle, providing a water line, and for establishing internal grazing paddocks using electric fencing. Under the lease, Metroparks will receive a single rent payment of \$405.00.

RECOMMENDATION:

I recommend that the board approves the lease agreement.
